APPROVAL OF MINUTES:

Selectman Shackford's List - No items

Selectman Arruda's List – Audit of Fire Dept 501C-3 – Motion by Shackford, seconded by Arruda to have the Fire Department submit documents regarding their 501C-3 status for audit by the Town Auditors during their January 2016 review. The motion passed 3-0.

Selectman King's List – No items

Assistant's List – Stacey had no items. Farinella noted that five RFP's for the 2016 - 2020 assessing contract have been received.

Arruda asked Chief Eldridge about how the fire truck being replaced will be disposed of. Chief Eldridge stated he has been looking into it and has found interest from the Redstone Department. Arruda asked that a plan be in place before taking delivery of the new truck.

Arruda asked Chief Eldridge about how the USDA grant request was progressing. Chief Eldridge explained that with Stacey's help they are close to being finished. Chief Eldridge explained that the grant money, if received, would be \$10,900 (15%) to go towards \$73,250 in warrant articles for Fire/Rescue Radio Communications, Rescue Tool (Jaws of Life) Upgrade and a Vehicle Exhaust System for Fire Apparatus. The Board explained that those items were removed from the list of warrant article requests for 2016. Arruda thought that the grant would be for the Rescue Tool with a much larger portion being covered. The Board directed Chief Eldridge and Stacey to go no further with the grant request.
