MADISON ZONING BOARD APPROVED MINUTES November 16, 2016

CALL TO ORDER: Mr. Lord, Vice-Chair, called the meeting to order at 6:20 P.M.

REQUEST FOR RE-HEARING - CASE # 16-04

Mr. Lord stated that Public Hearing convened on October 19, 2016 for an Appeal of Administrative Decision by Attorney Christopher Meier, Agent for Terrance Hurd of 19 Middle Shore Drive, Map 105/Lot 117 for property located at 17 Middle Shore Drive, Tax Map 105/Lot 118 and owned by Greyson and Jennifer Merrill.

This Appeal of Administrative Decision was **DENIED** by a unanimous vote for the following reason:

1. The Application was not filed in a timely matter pursuant to RSA 677:2 and reiterated in the Town of Madison Zoning Board of Adjustment Rules of Procedure.

DISCUSSION OF THE BOARD:

Mr. Lord stated the following:

- 1. That the appeal was filed on the 33rd day.
- 2. Town Hall is closed every Friday and every Friday is not a legal holiday.
- 3. The dictionary definition of a legal holiday does not list every Friday.
- 4. There is no new information given in this request for a re-hearing.

Mr. Sosnoff stated that Federal and State offices including the US Post Offices are open on Fridays and that particular Friday was not a legal holiday.

MOTION: Mr. Lord called for a Motion: Mr. Sosnoff made a Motion to Deny as the case was not filed in a timely matter. Mr. Anderson seconded.

DELIBERATION ON THE MOTION:

Mr. Anderson stated that the Madison ZBA By-Laws use 30 calendar days.

Mr. Sosnoff stated that the Application was filed late and there is no reason to reverse their decision to deny.

Mr. Lord read the following into the record:

TITLE XXV HOLIDAYS

CHAPTER 288 HOLIDAYS

Section 288:1

288:1 Holidays. – January 1; the third Monday in January, known as Martin Luther King, Jr. Civil Rights Day; the third Monday in February, known as Washington's Birthday; the last Monday in May, known as Memorial Day or, on a date to coincide with the federal observance if it is held on a different day; July 4, known as Independence Day; the first Monday in September, known as Labor Day; the second Monday in October, known as Columbus Day; the day on which the biennial election is held; November 11, known as Veterans Day; Thanksgiving Day, whenever appointed; and Christmas Day are legal holidays.

Mr. Lord emphasized that this Section 288:1 Holidays does not list every Friday as a holiday.

Mr. Hughes stated that the applicant is quoting a case when the office is closed on weekends and the applicant is interpreting that case wrong. Weekends are Saturdays and Sundays. Mr. Hughes stated that the applicant violated the 30 day window to appeal.
