## OTHER NEW BUSINESS OR MEMBER'S "LIST" ITEMS:

- 1. Chuck reported that the new concrete pad was complete for the scrap metal roll-off container and was working very well.
- 2. Paul did some research and found that North Country Recycling was bailing cardboard. He will look further into what the process may be whereas we could sell our cardboard to them. Also, there may be opportunities for other bailing with them.

- 3. Paul also spoke with the Conway Transfer Station about sending our paper and possibly other commingled items to them for bailing and they seemed receptive. Details will need to be discussed to see if it is feasible.
- 4. We also discussed the possibility of having the town chipper "stored" at the transfer station to be used for chipping the brush pile vs. burning. There could be several benefits as we could chip anytime vs. dealing with burning restrictions and we would be recycling by making a usable product for compost or mulch.
- 5. Dave will contact Russ Lanoie to see if he might stop by to give some advice on the best way to use our new compost area.
