**Hazardous Waste Info:** No progress yet.

**Mattress Recycling:** Chuck will review the information at tuck.com to see if it would make sense to provide that info at the transfer station and potentially add it to our website. This would give residents info on other options to mattress disposal rather than having to pay at the transfer station.

**Cardboard at NCR:** No progress. Paul and Dave to follow-up.

**Non-Resident Coupons:** Bob did a good job of designing a new non-resident coupon and process. We discussed it and made suggestions. We determined that it was above our pay grade and kicked it upstairs. Bob will go to the BoS to review it and get their input on resolution to the process.

**Compactor:** Not much progress. Paul, Dave and Chuck to follow-up on options and potential costs for the options for repair replacement or addition to the compactor situation.

**2017 Objectives:** Dave got a little direction from NRRRA and Regan Pride but more follow-up is needed. Several other towns have undertaken the same type of analysis. Dave downloaded a few of their planning or results documents and is reviewing them.
