 RSA 91-A:3 II (e) Consideration or negotiation of pending claims or litigation which has been threatened in writing or filed against the body or agency or any subdivision thereof, or against any member thereof because of his membership in such body or agency, until the claim or litigation has been fully adjudicated or otherwise settled.

 RSA 91-A: 3 II (f) Relative to adult parole board.

 RSA 91-A: 3 II (g) Relative to county correctional facilities.

 RSA 91-A: 3 II (h) Relative to business finance authority.

 RSA 91-A: 3 II (i) Consideration of matters relating to the preparation for and the carrying out of emergency functions, including training to carry out such functions, developed by local or state safety officials that are directly intended to thwart a deliberate act that is intended to result in widespread or severe damage to property or widespread injury or loss of life.

 RSA 91-A: 3 II (l) Consideration of legal advice provided by legal counsel, either in writing or orally, to one or more members of the public body, even where legal counsel is not present.

Description of the discussion and final decisions: **Based upon the interviews held on February 13, 2018 the BOS and DPW Committee unanimously decided to offer applicant Jon Cyr the position of**

DPW Director. Cyr accepted the offer. The start date for Cyr will be March 5, 2018 at 1:00pm with a starting salary of \$65,418.57 (Step 20 Grade 15) as per contract to be signed by Cyr and the BOS out of session.

Minutes and decisions reached in nonpublic session shall be publicly disclosed within 72 hours of the meeting, unless, by recorded vote of 2/3 of the members present, it is determined that divulgence of the information likely would affect adversely the reputation of any person other than a member of the body or agency itself or render the proposed action ineffective. In the event of such circumstances, information may be withheld until, in the opinion of a majority of members, the aforesaid circumstances no longer apply.
