DISCUSSION ITEMS

- Discussion of warrant article for Town meeting: Paul wanted to discuss the approach at Town Meeting of the
 project to obtain a second compactor. Bob will present the warrant article for an expendable trust fund for the
 compactor and explain the need and plan for acquisition. Paul and Dave can add support for the benefits as
 necessary.
- 2. Discussion of disposal of propane tanks: The committee needed to clarify the process for disposal of propane tanks and North Country Recycling's requested procedure. Small "camp stove" tanks can just be thrown into the scrap metal container. The 15 lb. "grill" tanks will be collected in an area near the office. When we call for a pick-p of the scrap metal, Jim will then use the loader to put all the 15 Lb. tanks on top of the pile in the roll-off so that NCR and easily get to them first to compromise the tanks for safety.

OLD BUSINESS:

- 1. **SWOT Workshop:** Dave passed out a memo from DES regarding a May 15th workshop in Concord regarding recycling, Pay as You Throw and recycling strategies. Paul plans to attend.
- 2. **Roll-Off Containers**: Paul brought up the status on researching new roll-off containers. Jim has requested a quote from Atlantic Recycling for covered containers. Bob will look into getting the roll-off project t on the CIP.

Dave will prepare numbers for potential savings from purchasing roll-offs for the town. We need to look further into types of roll-off covers that might be available/practical.
