## **APPROVAL OF MINUTES:**

**Motion** by J. Shackford, seconded by Arruda, to approve the minutes of a non-public session on October 23<sup>,</sup> 2018 as written. The motion passed **3-0**.

**Motion** by J. Shackford, seconded by Arruda, to approve the minutes of December 18, 2018 as written. The motion passed **3-0**.

## **APPROVAL OF MANIFESTS:**

**Motion** by J. Shackford, seconded by Arruda to approve the Manifest of December 31, 2018 – January 11, 2019 in the amount of \$282,058.16. The Manifest breakdown is as follows: \$82,090.63 for Accounts Payable; \$27,967.71 for payroll; \$7,923.58 for payroll liabilities; \$14,076.24 for New Hampshire Retirement; and \$150,000.00 for MES. The motion passed **3 -0.** 

**DISCUSSION ITEMS/NEW BUSINESS** – There was none.

**OLD BUSINESS** – There was none.

**Selectman Arruda's List** – Arruda stated that about \$150,000 will be turned back to the general fund from the 2018 budget.

Arruda asked Director Cyr for clarification on his payroll numbers for Parks & Rec (P&R). with this last pay run. There were 31 hours charged out of P&R. Cyr explained that he budgeted his part-time labor as half in highway and half in P&R feeling the numbers will balance throughout the year. Cyr was basing it the 1664 number of hours that the NHRS allows retired part-time employees to work. Cyr added that the plowing done at the school and library comes from the P&R line. Arruda is concerned that this method will not reflect a true picture. J. Shackford sees it as a budgeting preference.

Cyr did not know where the numbers for that line came from. Stacey spoke up and explained that she came up with those numbers using averages over the last three years. It was discussed that some highway hours have traditionally been used to do P&R when extra time is needed in those places.

King suggested taking the P&R wages line and put it into DPW salaries. Arruda went further suggesting creating a new line under DPW for P&R. Stacey explained that the state reporting is done in such a way that a change like this would convolute the numbers. King remarked that the Transfer Station is also under DPW.

Arruda suggested leaving it as it is and if the lines run over, they run over. Stacey will check with other towns to see how they handle this same situation.

**Selectman Shackford's List** – See you next year.

**Selectman King's List** – King suggested instituting an "Employee of the Year" form of recognition for town employees. Recognition could be made in the Town Report. Arruda and J. Shackford agreed with the idea noting we have a good staff of people. It was suggested that department heads submit an employee to the Town Administrator and they could be recognized at Town Meeting.
