**ReVision Energy Letter of Intent and Exclusivity Agreement** – A letter of intent was received from Revision Energy regarding the proposed solar array project. This letter of intent was sent to town counsel for review and several changes were made. The changes made were shown to Revision Energy and the only concern they had was with the confidentiality portion hoping to retain the ability to protect proprietary information. King asked Downs if this could be reworded to make it more specific, Downs will look into it. L. Shackford asked if there is a timeframe to get this signed. Downs stated it could be done after Town Meeting. The Board feels that the fact that this is being put on the warrant already shows good faith that we are moving forward and would like to wait until the Town has a chance to vote before signing.

**LED Smart Start Lighting Upgrade Update** – Downs had estimated figures for the electricity usage compared to average of 2016/2017:

The Board was please to hear these statistics.

**Request for Change to Snowmobile Regulations** – A request was received January 17th through the Town's Attorney regarding the closing of Ami Kennett Road to snowmobile traffic. The letter was from East Madison Rd property owner Samuel Bourne and read aloud and stated as follows:

"It has come to my attention that the Selectmen's snowmobile regulation permitting snowmobile travel on Ami Kennett road, has in fact, contributed to and promoted the unauthorized use and trespass of snowmobiles on my private access road and property. The snowmobiles come from the scrub oaks snowmobile club and travel up Ami Kennett road, cross east Madison road onto the Roger Cyr's property, and then onto my private access road and property. Therefore, directly interfering with the reasonable use of my property. Their trespass has also interfered with the maintenance and snowplowing efforts of my private access road, which again interferes with my use of my property. As such, I ask that you have town officials take all necessary steps to prohibit this abuse. The snowmobile club alleges that they do not need, or use, Ami Kennett road, but evidence on the ground proves otherwise. Madison police have also been contacted.

So, in an effort to prevent more litigation with the town, I request that you have town officials take all necessary steps to close Ami Kennett road to snowmobile use.

If no action is taken by the town within the next <u>48 hours</u>, I will have no other choice but to file suit, and include the town as an additional defendant for their participation and contributing efforts to cause undue harm to my use of my property."

L. Shackford clarified that this request was not addressed within the 48 hours because the Board did not have a meeting scheduled until tonight.

J. Shackford stated that the Madison Police and NH Fish and Game have done investigations into this issue. There is an ongoing lawsuit for the snowmobile club regarding this issue and J. Shackford hesitates to get involved. Chief Colby stated that one person has admitted involvement and nothing points to this being a snowmobile club issue. J. Shackford was of the understanding that the Ami Kennett Road was impassable due to a logging operation. Chief Colby stated if someone goes onto the Bourne property that could be treated as criminal trespass.

Jordann Firman stated that their neighbor Davis has permission to pass over their land. Arruda noted that even if someone is traveling from Ami Kennett Road over the East Madison Road, it has nothing to do with the Town. King was of similar opinion. Chief Colby expressed concern that if the Board did close the road it could be construed as the Town being somehow at fault. J. Shackford does not see the need for a public hearing.

Jordann Firman is of the understanding that Bourne's property is under contract so this may be a moot issue because only themselves and Davis use that portion of Ami Kennett Road.

Arruda asked that L. Shackford contact the Town's attorney and asked her to draft a response to Mr. Bourne encapsulating the Board's discussion and decision.

OLD BUSINESS - There was none.

**Selectman King's List** – King asked Dave Charrette to look into have a berm removed from the snowmobile trail on Lead Mine Road where it goes out to the powerlines as it presents a hazard. Charrette responded that the berm was removed about two weeks ago and that any issue is the result of Asplundh Tree Service's use of a skidder. King thanked Charrette.

**Selectman Shackford's List** – J. Shackford stated that every week the Town Hall receives correspondence from the public. J. Shackford noted a letter received expressing the appreciation for Officer Mosher's kind and compassionate actions in handling the death of a beloved dog that was hit by a car. Also received was a complimentary letter recognizing Sergeant Hayford and Officer Martin's competence and character in the handling of a car accident on Route 16. The Board will send letters to these officers thanking them for a job well done. J. Shackford also read a letter received from a Transfer Station patron in response to being notified that we had a check returned for insufficient funds. The letter contained strong language that was deemed inappropriate and unnecessary. Arruda noted that the fees collected were to cover what was charged by the bank and no more.

# Selectman Arruda's List – No items.

Administrator's List – L. Shackford stated that there will be notices mailed to select property owner informing them that their property is on the list of being visited in 2019 as part of the assessing re-valuation process. This change notification was prompted by a policy change with our assessing company.
