Ohlson knows that the ZBA struggles with this issue and feels it would be a better use of time to meet with the ZBA and the Code Enforcement Officer to discuss the issue together. Ohlson asked that Land Use Administrator King arrange a joint meeting to address this issue suggesting in the month of April.
