CONSERVATION COMMISSION MINUTES May 2, 2019

Call to Order: McKenna called the meeting to order at 7:09pm.

Approval of Minutes:

Motion by Lutjen, seconded by Slader to accept the minutes of the March 2, 2019 meeting as written. The motion passed **5-0**.

Public Comment:

Noreen Downs informed the Commission and those watching on cable tv, that Madison TV is looking to hire new programmers. Contact Madison TV if interested.

The Madison Energy Advisory Board Chair, Noreen Downs explained that they have been working with Revision Energy over the past year to address the energy cost of the Town buildings. Downs presented the plans for the solar array panels which will be located on 2 fenced-in acres behind the Burke Field ball fields. There will be 364 panels in 2 rows and will not interfere with the access to the Ward Parcel Conservation Land. MEAC verified with the Fire Chief Clark that there will be no issue with future fireworks in the area. This power purchase agreement requires no money down for the town. The plan is to start this summer and complete by December, 2019.

Lutjen inquired about any maintenance requirements from the town? Downs – only grass cutting. Slader asked what other communities worked with Revision Energy? Downs – Durham, Brentwood, Andover and Concord.

Downs will bring their remarks back to the MEAC for discussion and consideration.
