**ARTICLE 2.** Shall the Madison School District raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein, totaling \$7,077,231.49? Should this article be defeated, the default budget shall be \$7,051,637.30 which is the same as last year, with certain adjustments required by previous action of the School District or by law or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only. (The School Board recommends this appropriation 5-0). (The Budget Committee does not recommend this appropriation 2-4).

**ARTICLE 3.** Shall the voters of the Madison School District adopt a school administrative unit budget of \$707,150 for the 2020-2021 school year in which \$255,370 is assigned to the school budget of this district? (The School Board recommends this appropriation 5-0). (The Budget Committee does not recommend this appropriation 1-6.)

**ARTICLE 4.** To see if the Madison School District will vote to raise and appropriate the sum of \$30,000 to be placed in the capital reserve fund previously established for the purpose of educating educationally disabled children. (The School Board recommends this appropriation 5-0). (The Budget Committee recommends this appropriation 7-0.)

**ARTICLE 5.** To see if the Madison School District will vote to raise and appropriate the sum of \$35,000 to be placed in the Building Capital Reserve Fund previously established for the purpose of capital repairs.
