 RSA 91-A: 3 II (i) Consideration of matters relating to the preparation for and the carrying out of emergency functions, including training to carry out such functions, developed by local or state safety officials that are directly intended to thwart a deliberate act that is intended to result in widespread or severe damage to property or widespread injury or loss of life.

Other persons present during the non-public session: **DPW Director Jon Cyr; Town Administrator Linda Shackford**

Description of the discussion and final decisions: **With J. Shackford recusing himself from the discussion, Cyr requested that J. Shackford be paid on a salaried basis to assist in complying with conditions as a retired NHRS employee. Motion by Mauro, seconded by Lord to approve such by a vote of 2-0.**

With J. Shackford recusing himself from the discussion, Cyr informed the Board that two of his department's employees have tested positive for COVID-19. Those two employees have not been at work since last week and will remain quarantined. All employees that were in contact with the two positive employees were sent home and have COVID-19 tests scheduled for tomorrow. None of the other employees have had any symptoms and will not return until receiving a negative result from tomorrow's test. Cyr asked the Board to consider paying the full and part-time employees for their time having to be out and not require them to use hours from their paid time off, noting the essential nature of their duties to the Town. Both Lord and Mauro agreed to this proposal.

Note: RSA 91-A:3(II) Minutes of proceedings in nonpublic session shall be kept and the record of all actions shall be promptly made available for public inspection, except as provided in this section. Minutes and decisions reached in nonpublic session shall be publicly disclosed within 72 hours of the meeting, unless, by recorded vote of 2/3 of the members present, it is determined that divulgence of the information likely would affect adversely the reputation of any person other than a member of the body or agency itself or render the proposed action ineffective. In the event of such circumstances, information may be withheld until, in the opinion of a majority of members, the aforesaid circumstances no longer apply.
