 RSA 91-A: 3 II (h) Relative to business finance authority.

 RSA 91-A: 3 II (i) Consideration of matters relating to the preparation for and the carrying out of emergency functions, including training to carry out such functions, developed by local or state safety officials that are directly intended to thwart a deliberate act that is intended to result in widespread or severe damage to property or widespread injury or loss of life.

 RSA 91-A: 3 II (l) Consideration of legal advice provided by legal counsel, either in writing or orally, to one or more members of the public body, even where legal counsel is not present.

Description of the discussion and final decisions: **Director Cyr, in light of the recent passing of**

Transfer Station Cairns, explained his plan to re-organize some of the DPW employees and will be taking over direct oversight of the Transfer Station eliminating the need for a Transfer Station Manager position at this time. Cyr expressed to the Board the great work of Attendant Jeff Bryan and requested that his rate of pay be increased to Grade 8 Step 15 bringing him in line with other DPW employees.

Motion by Shackford, seconded by Lord to increase Bryan’s rate to Grade 8 Step 15 effective August 11, 2019.

Minutes and decisions reached in nonpublic session shall be publicly disclosed within 72 hours of the meeting, unless, by recorded vote of 2/3 of the members present, it is determined that divulgence of the information likely would affect adversely the reputation of any person other than a member of the body or agency itself or render the proposed action ineffective. In the event of such circumstances, information may be withheld until, in the opinion of a majority of members, the aforesaid circumstances no longer apply.
