 RSA 91-A: 3 II (h) Relative to business finance authority.

 RSA 91-A: 3 II (i) Consideration of matters relating to the preparation for and the carrying out of emergency functions, including training to carry out such functions, developed by local or state safety officials that are directly intended to thwart a deliberate act that is intended to result in widespread or severe damage to property or widespread injury or loss of life.

 RSA 91-A: 3 II (l) Consideration of legal advice provided by legal counsel, either in writing or orally, to one or more members of the public body, even where legal counsel is not present.

Description of the discussion and final decisions: **Director Cyr informed the Board of the loss of the Town's Mechanic as of November 16th. Director Cyr asked that the Board agree to have him fill an**

entry level Technician position instead of filling the mechanic position for now. This would allow time for Cyr to take a look at the best way to man the department citing the ability to use mobile mechanics should the need arise. The Board agreed to hire a Technician at Grade 8/Step 15.

In the event of such circumstances, information may be withheld until, in the opinion of a majority of members, the aforesaid circumstances no longer apply.
