Description of the discussion and final decisions: Chief Clark brought to the Board his request for an increase to his stipend. After discussion it was agreed that the Chief's stipend will increase from \$20,000 to \$27,500 with still no eligibility for points. The member reimbursement line of the budget will decrease from \$47,000 to \$40,000.

In the event of such circumstances, information may be withheld until, in the opinion of a majority of members, the aforesaid circumstances no longer apply.
