 RSA 91-A: 3 II (f) Relative to adult parole board.

 RSA 91-A: 3 II (g) Relative to county correctional facilities.

 RSA 91-A: 3 II (h) Relative to business finance authority.

 RSA 91-A: 3 II (i) Consideration of matters relating to the preparation for and the carrying out of emergency functions, including training to carry out such functions, developed by local or state safety officials that are directly intended to thwart a deliberate act that is intended to result in widespread or severe damage to property or widespread injury or loss of life.

 RSA 91-A: 3 II (l) Consideration of legal advice provided by legal counsel, either in writing or orally, to one or more members of the public body, even where legal counsel is not present.

Description of the discussion and final decisions: **Shackford asked the Board to consider an increase for Code Enforcement Office Robert Boyd for 2024 noting he has been at the same rate since 2022. The Board agreed to a salary of \$49,000.**

Shackford asked the Board to consider an increase for Administrative Assistant/Land Use Administrator Kate Young for 2024 noting she is still at the rate she was hired at. The Board agreed to an hourly rate of \$23.50

Shackford asked the Board to consider an increase for herself as Town Administrator for 2024 noting she has been at the same rate since 2022. The Board agreed to a salary of \$89,000.

Note: RSA 91-A:3(II) Minutes of proceedings in nonpublic session shall be kept and the record of all actions shall be promptly made available for public inspection, except as provided in this section. Minutes and decisions reached in nonpublic session shall be publicly disclosed within 72 hours of the meeting, unless, by recorded vote of 2/3 of the members present, it is determined that divulgence of the information likely would affect adversely the reputation of any person other than a member of the body or agency itself or render the proposed action ineffective. In the event of such circumstances, information may be withheld until, in the opinion of a majority of members, the aforesaid circumstances no longer apply.
