 RSA 91-A: 3 II (i) Consideration of matters relating to the preparation for and the carrying out of emergency functions, including training to carry out such functions, developed by local or state safety officials that are directly intended to thwart a deliberate act that is intended to result in widespread or severe damage to property or widespread injury or loss of life.

 RSA 91-A: 3 II (l) Consideration of legal advice provided by legal counsel, either in writing or orally, to one or more members of the public body, even where legal counsel is not present.

Description of the discussion and final decisions: **The Board discussed the inquiry received on February 5, 2024 from the NH Retirement System regarding hours worked by Josh Shackford in his capacity as Director of Department of Public Works.**

The Selectboard affirmed, with a MOTION by Arruda, seconded by Price, that Shackford's employment in the capacity of Director of Department of Public Works is part-time with the understanding that he will work less than thirty-five hours per week to maintain his part-time classification. The motion passed 3-0.

The Board agreed that Chairman Mauro will sign the NHRS attestation out of session.

Note: RSA 91-A:3(II) Minutes of proceedings in nonpublic session shall be kept and the record of all actions shall be promptly made available for public inspection, except as provided in this section. Minutes and decisions reached in nonpublic session shall be publicly disclosed within 72 hours of the meeting, unless, by recorded vote of 2/3 of the members present, it is determined that divulgence of the information likely would affect adversely the reputation of any person other than a member of the body or agency itself or render the proposed action ineffective. In the event of such circumstances, information may be withheld until, in the opinion of a majority of members, the aforesaid circumstances no longer apply.
