2025; at which time, should the agreement expire, Shackford will continue as an employee at will subject to the same duties, salary, and benefits as provided in the agreement until her employment is terminated by either party or the parties enter into a new agreement.

The Board deemed the protections provided to both the Town and Shackford as fair.

Motion by Mauro, seconded by Price to sign the agreement with an implementation date of today, March 5, 2024.

In the event of such circumstances, information may be withheld until, in the opinion of a majority of members, the aforesaid circumstances no longer apply.
