ARTICLE 2. To see how the Town will vote by official ballot on the proposed amendment, as recommended by the Planning Board, to the Town Zoning Ordinance as follows:

Are you in favor of Amendment No. 1 to the Madison Zoning Ordinance as proposed by the Planning Board as follows: to amend Section 1.3.B., Existing, Non-conforming Uses, to restructure this section and to clarify the requirements that a reconstructed structure must be in the same location and have the same dimensions and bulk as the existing structure except where a difference would make the reconstructed structure less nonconforming, and to add "the shoreland setback" in place of "the high-water line" to the setback requirements for expanded structures, and to omit the requirement that an expanded structure is limited to 50% of the existing first floor footprint.
