Description of the discussion and final decisions: **The Board discussed and reviewed the recommendation made by Director O’Donnell for the hiring of Ryan Doonan as a part-time summer camp counselor.**

**O'Donnell explained that a counselor will be leaving for a new job and the need for coverage the last few weeks of camp is necessary. O'Donnell responded yes to Price's question that O'Donnell is keeping a close eye on the counselor wage line.**

**Motion by Gray, seconded by Price to hire Doonan as a part-time summer camp counselor at a rate of \$18/hour. The motion passed 3-0.**
