Description of the discussion and final decisions: **The Board continued their January 7, 2025 review of a request for relief of interest and penalties accrued due to late property tax payment for Map 121 Lot 16.**

The Tax Collector responded to the Board's questions of how the notification process works explaining the numerous USPS notification sent prior to any liens being done. The Board also reviewed the property tax payment history for the property.
